Faeces - If a child/adult comes in contact with the school dog's faeces some germs could be transferred	Μ	<ul> <li>The school dog will only be walked under adult supervision.</li> <li>No child will pick up the dog's faeces.</li> <li>Dog hygiene box to include bags, anti-bacterial gel and wipes.</li> <li>The adult in charge of the dog is responsible for removing any faeces and disposing of them appropriately.</li> <li>In the unlikely event that a child finds faeces on the school field/playground they will report it to an adult.</li> <li>Benji will be trained to go to the toilet in an allocated area away from the children. Evacuation due to fire alarm- Children could be harmed if the dog gets in their way when leaving the building.
