- increasing the extent to which disabled pupils can participate in the school curriculum, which includes teaching and learning and the wider curriculum of the school, such as participation in after school clubs, leisure and cultural activities or school visits
- improving the environment of the school to increase the extent to which disabled pupils can take advantage of education and associated services which includes improvements to the physical environment of the school and physical aids to access education
- improving the delivery to disabled pupils of information, which is provided in writing for pupils who are not disabled. eg. handouts, timetables parents and be made available within a reasonable timeframe textbooks and information about school events. The information should take account of the pupils` disabilities and the preferred format of pupils and

data collection, questionnaires and parental discussions. The school will make itself aware of local services, especially those provided through the Isle of Wight As part of the school's continued communication with parents, carers and other stakeholders we continually look at ways to improve accessibility through Council, for providing information in alternative formats when required or requested for the benefit of both students and their parents.

# The Current Range of Disabilities within Queensgate Foundation Primary School

The school has children with a range of disabilities which include cerebral palsy, spina-bifida, and hydrocephalus. When children enter school with specific We have a few children who have asthma and all staff are aware of these children. The children keep their named inhalers on them disabilities, the school contacts the LA professionals for assessments, support and guidance for the school and parents.

All medical information is stored electronically via SIMs, collated and available to staff, on the staff noticeboard, and next to the central first aid point. Some children have allergies or food intolerances/cultural food choices; where required pupils have named Epi-pens. We have competent First Aiders who hold current First Aid certificates.

All medication is kept in a central safe and secure place which has easy access for First Aiders and staff members. Administration of Medicines consent forms are filled in by parents outlining the illness and amount and time of medication. All medication that is given is recorded.

### Delivery of the Curriculum

- School staff receive training in making the curriculum accessible to all students and are aware of its importance. There are high expectations of all
- All staff are made aware of the needs of individual students and the school undertakes to adapt existing or purchase new equipment whenever possible in order to meet these needs.
- The school will continue to seek and follow advice of services, such as specialist teacher advisors and SEN inspectors/advisors, and of appropriate health professionals from the local NHS
